Subject:	Victory Neighborhood: Proposed Plan Modification #6

The NRP Policy Board approved the Victory Neighborhood Action Plan on November 20, 2000. Minneapolis City Council approval was on December 29, 2000. The Plan did not include an environmental section or any environment strategies. The neighborhood residents have shown a strong interest in the Ryan Lake and Trail project and want to establish a more active role in the development and protection of the neighborhood's environmental assets.

A new environmental plan section, goal, objectives and two strategies were developed and presented to the Victory Neighborhood Association (ViNA) Board at its January 2004, meeting. The Board approved this addition to the Neighborhood Action Plan, the reallocation of \$5,000 to fund Strategy 1.2.1, and notification to the neighborhood residents. The attached Plan Modification #6 was approved at a neighborhood-wide meeting on February 25, 2004 and reviewed by the Management Review Team.

I have reviewed the attached proposed plan modification and find that:

- 1. The modification requests approval of a new Environmental section, goal, objectives, and two new strategies and the reallocation of \$5,000 between an existing strategy in the approved Neighborhood Action Plan and a proposed new strategy.
- 2. ViNA followed the process required by the NRP policy, "Changing Approved Neighborhood Action Plans and Early Access Requests (amended September 5, 1995)."
- 3. The modification is needed to address resident concerns about development and protection of the neighborhood's environmental assets.
- 4. The VINA Board approved the plan modification request at its January 2004 meeting and the modification was approved at a neighborhood wide meeting on February 25, 2004.
- 5. The modification is both reasonable and appropriate.

6. The modification does not change the amount of NRP dollars committed to the neighborhood for its Action Plan.

Under the Policy Board policy, "Changing Approved Neighborhood Action Plans and Early Access Requests (amended September 5, 1995)," these findings indicate that the addition of a new strategy to an approved Neighborhood Action Plan requires review by the Management Review Team, and approval of the Policy Board, and the City Council.

Issues identified in the preliminary legal review have been incorporated into the plan modification. No concerns were raised and no modifications or changes were recommended by any members of the Management Review Team.

Based upon these reviews and the request of the neighborhood, I recommend that that Policy Board adopt the following resolution:

RESOLVED: That the Minneapolis Neighborhood Revitalization Policy Board (Board) hereby approves Plan Modification #6 to the Victory Neighborhood Action Plan, which adds a new plan section, VIII Environment Plan, goal, objectives and two new strategies; and,

RESOLVED FURTHER: That the Board hereby authorizes the Director to: 1) request City approval of the addition of a new plan section, goal, objective and strategy to the Victory Neighborhood Action Plan; and 2) authorize the appropriate City officers to enter into any contracts or agreements necessary to implement the activities above.
