Subject: Community Oriented Public Safety Initiatives Reserve Fund / Final Report

On August 18, 2003 the Policy Board passed a resolution dedicating \$1 million of NRP's Phase II revenues to "community oriented public safety activities" in 2004. The funds used to support this Community Oriented Policing Services Reserve Fund were deducted from the dollars available for allocation to neighborhoods. The neighborhood allocations approved by the Policy Board on April 19, 2004 did not include this \$1 million set aside.

The Policy Board decided to use an RFP process to allocate the COPS Reserve Fund and in January 2004 a notice to all neighborhoods was issued to solicit police and community proposals for effectively using these resources in 2004. In April the Policy Board approved funding for 16 proposals covering 45 of NRP's 70 neighborhood organizations and every police precinct in the city. The projects and policing programs included in the proposals were joint efforts of neighborhoods and the Police Department. Police Precinct and Department approval was required to be eligible for support from the COPS fund. The Board approved the projects for funding at its April 19, 2004 meeting and the Minneapolis Police Department began implementation immediately thereafter. The funds were to be used to support more than 21,000 hours of police service.

The final results of the 2004 effort have now been received and the Police Department has completed its billings for the hours used to support the COPS initiatives. The results for each supported proposal are attached. The figures show that the projects funded from the COPS Reserve Fund did not use all of the police hours they were allocated or expend all of the dollars that they requested. Of the 21,386.3 hours of service funded, only 17,684.6 were actually used. A total of \$165,880.04 remains as the unspent balance.

The Board has several options that it could pursue:

1. Leave the funds in the COPS Reserve Fund and issue a new RFP requesting neighborhood and police collaborations that could be funded with the remaining balance of \$165,880.04. (This would be similar to the treatment of the Affordable Housing Reserve Fund).

- 2. Close the COPS Reserve Fund and allocate the remaining balance of \$ 165,880.04 to the neighborhoods to increase the funds available to them for their priorities and Phase II activities. (The amount per neighborhood would vary considerably but would be proportionate to their percentage of the total allocated in April 2004. A table showing the results of this distribution is attached).
- 3. Close the COPS Reserve Fund and allocate the remaining balance of \$ 165,880.04 to the NRP contingency allocation. (The contingency fund was approved at \$1.5 million in April 2004 as part of the allocation decisions made at that time.)

After reviewing these options, it is my recommendation to the Policy Board that it adopt the second option by closing out the COPS Reserve Fund and reallocating the unexpended balance of \$ 165,880.04 to the neighborhoods. Neighborhood allocations have been severely reduced in Phase II and for many neighborhoods the additional funds received through this reallocation will make a difference in their activities. Some of these funds may be used to fund new policing initiatives but that decision should be made by the neighborhoods through their plan development and decision making processes.

I am, therefore, recommending approval of the following resolution:

RESOLVED: That the Minneapolis Neighborhood Revitalization Program (NRP) Policy Board expresses its appreciation to the Minneapolis Police Department and to the neighborhoods that implemented projects/programs funded by NRP's Community Oriented Policing Services (COPS) Reserve Fund for their efforts to specifically improve public safety and the results that they achieved;

RESOLVED FURTHER: That the COPS Reserve Fund was for activities to be completed in 2004 and that the Fiscal Year has ended and all billings have been received and processed for payment;

RESOLVED FURTHER: That the remaining unexpended balance of \$165,880.04 be reallocated proportionately to the neighborhoods and increase their respective Phase II allocations accordingly.
