

## Policy Board gives three neighborhoods approval to begin Phase II planning

On May 21, 2001, the NRP Policy Board approved the first three participation agreements for neighborhoods ready to begin Phase II planning. All three neighborhoods, Powderhorn Park, Seward, and Stevens Square/Loring Heights, have either spent 85 percent of their Phase I allocation or have contracted 95 percent of that same allocation – the required threshold for entering Phase II. Last November, the Policy Board also approved advance Phase II funding so the Jordan Area Community Council could begin working on its Phase I plan review and Phase II participation agreement.

A participation agreement serves as a blueprint for the NRP planning process. The document outlines how the range of community interests will be involved;

details how plan strategies will be developed and prioritized; and explains the process by which the neighborhood action plan will ultimately be approved.

Developing a neighborhood action plan is a process through which a broad spectrum of residents and other stakeholders define what they want for their community. Neighborhood action plans define the vision, goals, objectives and strategies for a neighborhood's future. When completed, an action plan serves as an outline for changing a neighborhood and making it a better place to live, work, learn and play. Before neighborhoods can begin Phase II planning, they must also complete a full review of their Phase I plan.

## Volunteers needed for Bassett's Creek wetlands planting June 23

Teams of volunteers will work to plant some 5,000 plants in the wetlands area near Bassett's Creek on June 23 from 9 a.m. until noon. Both the Bryn Mawr and Harrison neighborhood associations are encouraging residents from other neighborhoods to join them in this important and exciting endeavor.

The Minneapolis Park and Recreation Board (MPRB) has already cleared buckthorn and other intrusive plants from the wetlands area. Volunteers may park on Washburn and Glenwood Avenues N., then walk down to the site on the path (south side of Glenwood) at the west end of Glenwood Bridge. Trowels, special boots, trash bags, and buckets will be provided. However, volunteers should bring their own gloves and mosquito repellent. Volunteers should also anticipate muddy conditions especially if it is raining. 

## Humphrey Center offering free training for neighborhood volunteers

Neighborhood organizations are facing an ever-increasing number of challenges that require the help of skilled volunteer organizers.

That is why beginning on Wednesday, June 20, the Humphrey Center's Minneapolis Training Program for Neighborhood Organizers will be providing free in-depth training for neighborhood volunteers.

The Humphrey Center's in-depth training program is designed to help volunteers learn organizing fundamentals and apply them effectively to their organization's unique situation. The training combines comprehensive coverage of organizing basics, trainings individually tailored to the individual needs of each volunteer and group, long-term follow-through, and group support from fellow neighborhood volunteers.

The program consists of six to eight two-hour weekly sessions and will kick off with a discussion entitled "Recruiting Volunteers." Other topics will be chosen by the participants and can include:

- \* Leadership development
- \* Issues identification
- \* Grassroots and foundation fundraising
- \* Organizing under-represented groups
- \* Running meetings and events
- \* Research
- \* Media and communication

In addition, several monthly follow-up meetings will be held so participating volunteers can share their experiences and exchange ideas on challenges and problems they are facing or have overcome.

The first meeting will take place on Wednesday, June 20 from 7:00-9:00 p.m. at the Northeast YMCA located at 2304 Jackson Street NE.

### 2nd Annual National Night Out Planning Week set for June 18-21

In order to help active block clubs prepare for National Night Out on August 7 as well as to encourage inactive and new block clubs to organize, CCP/SAFE is promoting the 2nd annual National Night Out (NNO) Planning Week June 18-21. Block clubs are asked to hold a NNO planning meeting so that block parties go smoothly when NNO arrives. Block clubs are groups of neighbors who get to know one another, who watch out for each other and report crimes and suspicious activity to 911. Those who hold a planning meeting between June 18-21 will qualify for a special prize drawing that includes gift certificates for restaurants, theaters, hotels, and grocery stores.

Planning meetings enable neighbors to make the necessary preparations for a successful NNO. Neighbors can decide such things as who will be responsible for bringing food and utensils, the types of activities that will be available for adults and children, and whether or not the street needs to be blocked off. Planning meetings are also a good time for neighbors to decide who will make invitations and how they will be distributed.

The Cedar Isles Dean Neighborhood Association (CIDNA) is currently seeking an experienced, PT independent contractor to serve as its Program Coordinator.

Program Coordinator duties include: organizing neighborhood outreach to increase community participation in CIDNA activities; assisting in organizing and implementing evaluation of Phase I Action Plan; assisting in organizing and implementing the planning of Phase II Action Plan; preparing required documents and reports for NRP as requested; documenting meetings; and serving as a liaison between CIDNA and governmental units.
