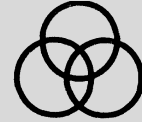

Minneapolis Neighborhood Revitalization Program News



Neighborhood allocations for Phase II approved by NRP Policy Board

The NRP Policy Board has taken the final steps needed to provide neighborhoods with allocations for Phase II. At the Board's April 19 meeting it approved the distribution of \$41,669,210 using the formulas adopted in March, with a minor adjustment that provides Phillips and Ventura Village with some additional resources to help support the American Indian Plan that will be a part of their Phase II Neighborhood Action Plans. American Indians produced and implemented a similar plan in Phase I.

The formulas used to make the calculations had been disseminated in January for neighborhood review and comment. The approval of the allocations by the Policy Board ended almost four years of uncertainty for neighborhoods. The amount available for distribution has dropped steadily since July 2000. The tax law changes adopted in 2001 and other actions that have occurred since that time reduced the funds available to the NRP from the Common Project from the \$131

million originally expected to be allocated to neighborhoods to the \$41 million allocated on April 19.

As part of its allocation action, the Policy Board also limited neighborhood expenditures during the first three years after they have an approved plan to 70 percent of the amount approved for their plan. This will help ensure that any future revenue shortfalls can be addressed without eliminating support for neighborhoods that enter Phase II later. The Board also indicated that 70 percent of the amount allocated to neighborhoods will need to be expended on housing or housing related programs, projects, activities or services in Phase II to ensure that the program meets its statutory housing investment obligation. It stopped short of making this a requirement for every neighborhood but indicated that neighborhoods should consider how much they can help as they develop their Phase II plans.

2004 Minneapolis & Saint Paul Home Tour tops 10,000 in attendance

More than 10,000 visitors made more than 47,000 visits during the 2004 Minneapolis and Saint Paul Home Tour on May 1-2, making it one of the most well attended tours in the event's 17-year history.

Coordinated and presented by the NRP, the 2004 Home Tour featured 50 homes—37 in Minneapolis and 13 in Saint Paul—and included five neighborhood tours aimed at giving visitors a more in-depth look at the communities supporting these homes.

Public Safety Reserve Fund proposals approved by Policy Board

On August 18, 2003 the NRP Policy Board passed a resolution dedicating up to \$1 million of NRP's Phase II revenues to "community oriented public safety activities."

Eligibility and Selection Criteria were approved by the Board on February 23, 2004 and distributed to neighborhoods on February 26. Responses to the Request for Proposals were due on April 1.

Fifty-seven of the 67 neighborhood organizations participating in the NRP were submitters or parts of collaboratives that submitted 22 proposals to NRP for funding consideration. A panel of distinguished and experienced experts in the public safety field reviewed the proposals and reduced the \$ 2,196,247 requested to the \$1 million available.

Proposals in every police precinct were funded and the \$999,942 approved by the Policy Board will provide 25,088 hours of police service to the neighborhoods of the city. The proposals supported, and the activities that will be funded, will soon be available on the NRP's Web site at www.nrp.org. The successful proposals were, by precinct:

11th annual Mississippi River clean-up May 15

The 11th Annual Mississippi Corridor Neighborhood Coalition (MCNC) River Clean-up will be held on Saturday, May 15 at 9 a.m., with headquarters at the Boom Island Park main site, 700 NE Sibley St.

MCNC and its co-sponsors, the Minneapolis Park and Recreation Board, the Mississippi Watershed Management Organization, and Hennepin County welcome all community members to participate. Volunteers can pick up bags and gloves and fan out into ten locations to eliminate unsightly debris from the upper Mississippi River in Minneapolis.

Volunteers and donations are still needed to make this year's event a success.

Tentative pick-up points include North Mississippi Regional Park, Boom Island, Camden Boat Launch, Edgewater Park (Lowry & Marshall), Mentor Building (between Plymouth & Broadway on West River Rd), Federal Reserve Bank, Bassett Creek: Cedar Lake Rd & Logan Avenue North (three blocks south of Glenwood), Father Hennepin Bluff Park (east end, Stone Arch Bridge, 6th Ave and Main St SE), Cedar Riverside: 4th St S & West River Road, and De La Salle High School (Nicollet Island).

At noon, volunteers will gather at Boom Island Park to trade trash stories, add up the pounds of trash collected, win door prizes and eat free food donated by area businesses. There will be environmental displays and entertainment will be provided by local musicians. The DNR's Minnaqua Program will feature a fishing clinic for children starting at 11 a.m.
